Petition to the House: On reflection, and as a way of emphasising the fact that we, the HMAS Sydney Assoc. (Inc. Vic.), still have the potential, with just over 300 active members, to increase the numbers of responses to the Petition to the House a lot further.

If we had continued with the longhand, pen/paper version which had 28 places for signatures on the Response Sheet, we had the potential with 300 plus members at 28 signatures per member of obtaining 8,400 signatures.

Yes, this would have involved a little effort by each of us to take the time to obtain these numbers, and yes, some of us managed to do just that, and then some. See the enclosed listing for those who have contributed thus far.

Request for Assistance from the HMAS *Hood* Association: In mid-August our Webmaster, Laurie Pegler, received an email from Rob White of the HMS *Hood* Association in the UK, asking whether or not we would be prepared to support a Nomination for an Award to David Mearns administered in the UK under the Imperial System. After a bit of to-and-fro with our Hon. Secretary, David Dwyer, the following was sent in response. (David Mearns was involved

in finding HMAS Sydney II, and was recognised with an Hon. Australian OAM).

My written response to this request reads thus:

Good afternoon Rob,

With reference to your recent email regarding the nomination of David L Mearns for an honour/Award via the Imperial System, I write to you on behalf of the HMAS *Sydney* Assoc. (Inc. Vic).

As President of the Association, it would not be right or proper for me to write anything which would support your nomination, as I for one do not know David Mearns personally. One of the first requirements here in Australia for Honours and Awards is one must know the Nominee personally.

I am aware of his contribution to the quest to find HMAS *Sydney* II, and I know of several widows, descendants, former shipmates and others who are eternally grateful that they now know where their loved ones lie.

Both these gentlemen were fully involved with David Mearns before, during and after the discovery of HMAS *Sydney* II, and would be in a far better position to assist you than would I.

To the best of my knowledge and belief, Bob is still involved with the organisation which funded and help carry out the search, and John was nominated as the Royal Australian Navy's representative during the search. John retains a position within Defence, and is fully involved at the RAN's Sea Power Center, Canberra, Australia.

Both gentlemen are very approachable and very cognisant of doing things correctly. I don't think you will be disappointed with my choices.
